Course Objectives

This includes knowledge of the nature of language and the physical means by which we produce speech, as well as the kinds of changes involved in normal and disordered speech production.

- **Unit 4**. Applied uses for transcription, including clinical transcription

Class Behavior

All students attending this class must be registered at the university and for the class by **September 12**, **2012**. Students are expected to have satisfactorily completed HESP 305 - Anatomy and Physiology of the Speech Mechanism prior to enrollment in this course.

Participation is mandatory for full marks. It is expected that each student arrive promptly, complete the attendance exercise, bring the necessary materials for class each day, and participate constructively in class. The textbook will be used on a daily basis and must be brought to each class. Part of being prepared includes completing all assigned reading or assignments for that day.

The use of technology for taking notes is strongly discouraged, however, not forbidden. Proper technology use during class time is restricted to note taking or viewing content related to class. Technology use is not permitted during quizzes and will result in a zero. Violation of this policy will result in a zero for the day's participation credit.
